A. Adam McKenty– Cortes Island Community Economic Development Commission

- Loss of tourism season
- CERB is assisting tremendously
- Many businesses have been flatlined
- Have been organizing calls with outside experts, most recently with Tourism Vancouver Island
- General community organizing work, community investment co-operative developed, business development and training series,
- Using survey monkey, conducting surveys
- Community Zoom town halls to provide updates which have been broadcast on local radio station, advertised on cortesisland.com, three conducted so far,
- Working with Regional Director and Staff to co-ordinate response on Cortes Island
- Good news story pandemic has accelerated work that was already underway

B. Ian Elliott – Pender Island Community Economic Sustainability Community Commission

- Complete slowdown of entire local economy, coping has been a challenge for the community, tourism has been impacted, real estate and construction less so, post office open with lots of mail coming through, Island Savings operating 2 days per week only, retired community staying home as much as possible
- Go Fund Me to raise bridge funding for local business
- Developing economic recovery plan
- Community resource centre has been resource hub
- Direct call centre for personal shopper and other services
- Individual outreach
- Liaising with partner groups and agencies
- Good news story a number of businesses have adjusted their models to continue to service the community

C. Mark Lasby – Quadra Island --Discover Islands Chamber of Commerce

- Chamber represents Quadra and Cortes
- District EOC has been set up
- TecHatchery has build COVID 19 website and offers Zoom webinars on a variety of topics, weekly Zoom session for Quadra businesses, has put in a proposal for residents to create 11,000 face shields but have experienced difficulties
- Only communication tool available is email
- Local regional government communicates through FB
- Good news stories through Zoom meetings people are leaving panic and into future plans in order to thrive, also possibility of jobs making face shields

D. Virtual Tourism Roundtable

- Virtual experiences bring sites and sounds of your community to visitors
- Need access to internet but it should not be complicated
- Needs to be collaborative, holistic and integrated
- Work on the long view 5 years out
- Work with who we are and what we have
- Ideas
 - i. Island farm cooking classes
 - ii. Nettles in your kitchen classes, recipes, field gathering
 - iii. Live broadcasts of yoga classes
 - iv. Felting kits and classes
 - v. Foraging for mushrooms
 - vi. Disc golf skills via YouTube
 - vii. Virtual wine tasting
 - viii. Picnic box of island products to enjoy at home
 - ix. Gulf Islands park reserve
 - x. Trail walks
 - xi. Farm tours
 - xii.endless
- Can we formalize this through a shared channel?

16:00:04	From Jessica Harkema : We haven't found that information either. I would assume gross as income and expenses do not necessarily fall in the same period. Also we had some business owners who managed to write their income down to 0 last year and still qualified for CERB with the \$5000 minimum income for 2019.
	I always suggest - ask your accountant, ask the CRA, and apply to see if you qualify.
	It's also important to note that it's no income for 14 consecutive days. That leaves a lot of flexibility on making income.
