- Circular Island Economies




This week's Resolutions can provide a roadmap for realizing rural island "values in action" going forward, all within the context of ecological and social justice.

The Resolution Process

Through team-based collaboration supported by our facilitators, participants in each Day 2 Action Lab will incorporate the framework of Doughnut Economics to developing outcomes-based 2023 Forum Resolutions.

Day 3 morning Action Lab Resolution groups will provide direction for programs, policies and advocacy for island communities to take on the topics, as well as the foundation for formal Resolutions to be formalized and endorsed by a majority of Forum participants.

Resolution *noun*

A formal expression or statement of feelings, opinion, will, wishes, intention or decision, often voted by an official body or assembled group

An expression or document containing authorization usually by a corporate board of directors of a particular act, transaction, agent, or representative.

The act of answering a problem, or stressing firm determination to achieve one's ends.


Formulating Our Resolutions

2023 Forum Resolutions may call upon any level of government -provincial, regional, local, and bodies such as Islands Trust, to respond to and address the special needs of BC's rural island communities. Resolutions may be shared with local and regional news media, RIEP members, stakeholders, supporters, and followers.

2023 Forum Resolutions will be formal written statements presented to the 2023 Forum Plenary during the closing session, followed by a brief Q&A, and votes on next steps for each Resolution.

Participants will formulate Resolutions using the following format:

§ Title of Resolution



8 *Resolved* The core expression of the Resolution—the desired action, solution, or outcome for the problem to be considered.

Facilitators, Moderators & Speakers



David Adams has been called a 'creative catalyst', 'visionary strategist', 'alchemist at heart', and 'a magical connector of dots' for his ability to turn napkin concepts and vague ideas into viable initiatives and partnerships. David co-founded THRIVE Bowen which looks to proactively develop and



implement solutions that substantively move the needle in regard to local, community-based food resiliency and sovereignty. He helps organizations and individuals discover and live their purpose, 'level up', and maximize revenues and potential. A transformational agent who sees paths forward where others might not, David is an adamant believer that enthusiasm, laughter, and love can inspire prosperity and a life well-lived.

Since his retirement on Galiano Island, Ed Andrusiak

has volunteered his time on inter-island projects such as the Experience the Gulf Islands community tourism plan. Most recently he co-authored the Southern Gulf Islands Local Area Food and Agriculture Plan that identifies priority actions to



transition to regenerative farming practices including exploring with First Nations the potential for seaweed and shellfish farming in the waters of the Salish Sea. Ed currently chairs the **Southern Gulf Islands Community Resource Centre** and is focused on food security and sustainable community tourism.

Dave Bodaly is a Snuneymuxw First Nations

photographer, genealogist, and cultural tour guide on Saysutshun (Newcastle Island). He's also a weaver, and has been teaching cedar weaving classes since 2007. A descendant of the Bodalys of Northamptonshire, England, Dave carries his great



grandfather's name Laxiya; he believes it's important to share his views about truth and reconciliation in a cultural perspective with all who are willing to listen and learn. Dave currently lives in Nanaimo.

Michelle Bonner leads grant-making and work with community partners in service of **Vancity**'s climate commitments to achieve net zero across its loan portfolio and to finance an equitable climate transition. Much of her work focuses on addressing the barriers to and opportunities in retrofitting



buildings to deeply reduce emissions and improve their resilience to climate impacts such as extreme heat events. Prior to joining Vancity, Michelle served as Vice President and Training Manager with Climate Smart, where she led the delivery of a training and certification program to help small and medium-sized enterprises measure and reduce their greenhouse gas emissions.

Graham Bradley is a 1st generation farmer who grows vegetables on 3 acres of wonderful peat in a fen named Good Earth Farm in Snnuyemux Territory. Alongside, he runs the **Gabriola Food Hub**, a small business which helps connect island producers with island businesses and folks. A Human



Geographer by education, he is an avid volunteer and has served as the President of the Gabriola Chamber of Commerce for 5 years and as a director on the board of the Gabriola Agricultural Co-operative for 3 years. He has lived on Gabriola Island for 8 years.

Francine Carlin moved to British Columbia in 1999, and with a background in business communications, organizational development, and change management, she established the Business Harmonizer Group in order to support family-owned businesses across Canada and the USA as a certified



Family Business Advisor. Soon after moving to Salt Spring Island in 2008, Francine's interest in business continuity led her to join the Salt Spring Community Economic Sustainability Commission (CESC), where she co-led the groundbreaking Rural Business Accelerator program and co-founded the Southern Gulf Islands Tourism Partnership. Throughout her tenure as CESC Chair, Francine championed a strategic approach to building community economic development. Expanding beyond Salt Spring, she led the successful call to include the Southern Gulf Island Region—the rural islands of Galiano, Mayne, Pender, Salt Spring and Saturna—into the scope of the Islands Coastal Economic Trust (ICET). In 2020, along with likeminded islanders, Francine co-founded the **Rural Island Economic Partnership Society (RIEP)** to further the economic resilience of BC's rural islands by connecting as a community, sharing ideas, and working together to achieve local socio-economic goals sustainably.

Jen Demler is one of the founders and co-owners of Ground Up Café & Catering – a recently opened small café on Gabriola Island with a focus on sourcing from island farms and producers, a healthy and inclusive work environment, and community engagement. Ground Up recently completed the



Circular Economy Accelerator Program and was named a Circular Leader. Jen will be speaking to their experience working with Synergy Foundation and VICEDA and the program, outcomes of the assessment and report, current successes, and what steps the café will be taking moving forward to further their efficiencies in the restaurant industry.

Marc Doll is a Quadra Island resident where he, his wife Jennifer and twin daughters Gaby and Charlotte live on Foot Forward Forest Farm—what they describe as a 40-acre, nascent regenerative farmstead. Marc is passionate about



soil health, regenerative agriculture and animal-based regenerative systems. Making a farm economically viable while integrating into and improving the natural systems is a key focus of Marc and his family. From pastured poultry, sheep, goats, pigs, ducks, and geese, to a growing sausage making business, Marc works every day to improve food security on Quadra Island.

Nature is at the core of biologist and writer **Ann Eriksson**'s work. The **author** of five adult novels and three non-fiction ecological literacy books for younger readers, Ann aims to live lightly on the earth. Her most recent non-fiction book, the award-winning, URGENT MESSAGE FROM A HOT PLANET:



Elizabeth May, as a 'toolbox for hope.' Ann is also the volunteer executive director of the Thetis Island Nature Conservancy. She lives, with gratitude, on Thetis Island, within the unceded traditional territory of the Hul'q'umi'num'-speaking Coast Salish People.

Alison Evans is co-founder of Gulf Island

Seaplanes, which she co-founded on the west coast of British Columbia with her husband and co-founder, Sean, in 2014. Drawing on a combined love of adventure and travel, she's worked hard to grow the business over the years, cultivating a strong



reputation for customer service, safety, and attention to detail. As an Indigenous female business owner and mother of four, the path has been challenging and rewarding; Alison credits the key to Gulf Island Seaplanes success to surrounding the business with strong and incredibly hard working staff. She is Gitxsan from the Hagwilget First Nation, living the past 17 years in Nanaimo on the beautiful lands of the Snuneymuxw people. Alison takes her role in being a strong representation of Indigenous business seriously— Gulf Island Seaplanes' vision is to grow as a diverse and inclusive airline and, along with their First Nations partnerships, to provide an unforgettable journey.

Kristi Fairholm-Mader (KFM) has always worked in the social impact sector. After returning to school to complete a business degree, Kristi began exploring social enterprise and enterprising approaches to social change and founded several social enterprise initiatives, including The Cleaning Solution. In 2014,



Kristi co-founded Scale Collaborative to support the growth of the social economy sector on Vancouver Island and beyond. Within Scale's family of organizations, KFM is the Managing Director of **Thrive Impact Fund**. She also is the Project Manager for the BC Social Procurement Initiative. Kristi lives in Victoria with her husband, 2 children and a very lazy husky.

Carol Fergusson, Executive Director for Gabriola

Arts Council is an innovative thinker and a creative problem solver. With a background in fashion, art, business and education, she leads arts administration with an inquisitive and holistic approach. Carol has been successful in bringing over



one million dollars in funding to the Gabriola Arts Council in the first three years of her role as ED, with half of that funding marked for two special projects. Carol enjoys working with community partners and her "big" thinking has brought multiple partners together in projects benefiting the community of Gabriola.

Lisa Fleming is a long- time resident of Pender Island, where she lives, raises her kids, and works as Executive Director of **Ptarmigan Arts**. Ptarmigan is a charitable arts organization that delivers community arts programs primarily on Pender Island, and to a limited degree on the other Southern Gulf



Islands and in Greater Victoria. tach people. His hobby grew into a business as a freelance artist supporting various ventures and non-profits with branding, digital media and murals. Adam and his wife/business partner Robin are animating the Comox and Campbell River cultural landscape with their prolific artworks in a variety of mediums, which are becoming a shared source of pride across communities.

Jody Lorenz has lived on Bowen Island for ten years and was one of the founding board members of Tourism Bowen Island Association (TBI), established in 2015. At first, TBI's activities focused

on economic development but recently, like many



other DMOs, TBI is transforming into a CDMMO – community destination marketing and management organization. In response to the pandemic and increasing local pressures and concerns, TBI is developing a community-based tourism master plan that strives to balance community wellbeing and environmental stewardship with a healthy, responsible tourism ecosystem.

Her past employment involved advocating for Harm Reduction as an Indigenous Liaison; connecting Indigenous Elders and Youth as a Youth Worker; and former Project Manager for the St. Michael's Residential School Project (Ne'nagwa'nakwala) to locate unmarked burials in 'Yalis.

Jami Scheffer is the new Director for The Hearth– Arts on Bowen, formerly the Bowen Island Arts Counci. Jami recently relocated to Bowen from the East Kootenays after many years of being involved in creating a vibrant, sustainable and creative community, and helping to form, shape and educate
